When I've asked other government bodies (mostly municipalities) to run a search, they've been able to run it over all the mailboxes in the organization. In this case, that would be all tre.state.ma.us addresses.

Do you have that technical ability? The IT team should be able to run such a search against the Microsoft Exchange server that hosts the office's emails.

I feel the two criteria "Limit the search to emails where boston.mfa.gov.il appears in the To, From, or CC lines" and "Limit the search to dates from 1/1/2025 through 5/21/2025 (inclusive)." should bring the number of records found down to a reasonable number.
